**Convention Report by Deborah Ploof, GMG Co-editor**

Friday Session: The VT State Grange Session started at 9 AM October 14<sup>th</sup> with the various committees meeting to discuss resolutions presented by August 1<sup>st</sup> to State Secretary. They also had to discuss any policies dated on or before 2015 and determine if the policy should be reaffirmed (kept as policy) or sunsetted (removed from policy). At 11 AM after the Officer's Entrance March, the session opened in the Sixth Degree and later lowered to Fourth degree to begin the work for the day. Roll call of Officers, Deputies, and Committees. Resolutions were introduced and reports from 3 auditor committees were presented as well as Secretary, Trust Officer, and Executive Committee. All were accepted as presented. The 2022-2023 budget was presented and then distributed to members present. It is required that the budget have a 24-hour layover, so it was again presented and approved on Saturday afternoon with a final budget of \$84,279.00. The session continued with reports from various committees including the Grange Center Board, New England Grange Building Trustee, and the various committees considering the resolutions in the delegate packet.

At 3 PM the Master's Address was presented by Worthy Master Joseph Goodrich. One section was assigned to the Good of the Order committee to write a resolution to increase gas reimbursement to \$0.40 due to high fuel costs. Grange Memorial service was presented by Worthy Chaplain Jennifer Nelson with the aid of the Graces, Secretary, Master, and Musician Barbara Thompson. 27 members have pasted to the Great Grange Above. Meeting was closed in the Fourth Degree.

Saturday Session: After the usual opening of the Grange, credentials report, minutes reading and approval, the election of officers began. It was interspersed with reports from standing committees and resolution consideration. You can find the list of officers in this edition of the GMG. Educational elections are reported under the EAF article by Lois Wakefield. The results of the deliberations on the resolutions are also reported in this GMG.

As mentioned before, the budget was approved after the 24 hour waiting period.

Members of the Assembly of Demeter were presented. Those present were Linda Sanderson, Kendal Holden, Errol Briggs, Lisa and Joseph Goodrich. Corporation meeting was held. **(Editor's note: Have you remembered to have your corporation meeting this year??)** Meeting was closed in the Fourth Degree. Silent Auction was closed and raised \$577.50 which, as voted by the session delegates, will be divided equally, and donated to Ronald McDonald House in Burlington and David's House in Lebanon. Grange Center 50/50 raffle was announced netting the Grange Center \$364.00.

well as toiletry items for those at Good Samaritan Haven. Awards from Lecturer for various contests including book reports and Community Service were presented. Winners for Community Service were first place winner Marble Valley: second place, Lake View: third place, Blue Spruce: and fourth place Milton Grange. Certificates with seals and stars for completing reports and submitting were handed out by Joe Goodrich.

**Installation of officers** was conducted by the installation team of Susan Hanlon, Joe Goodrich, Alice Daley, Janice Rousselle, and Deborah Ploof.

### Agriculture and the Environment Department Report- 2022 Director Jenny Nelson

A review of this past year has shown some changes in agriculture. Prices moderated upwards for dairy, but only due to the fact that droughts countrywide indicated some loss in feed production and rising costs for fuel. Local food sources in Vermont remain a priority to its citizens, as well it should. Having the big picture view and understanding the relevance of limited resources and global warming, we must stay diligent in our efforts to maintain the resources we have-our land and our water.

In 1977, our state of VT made policy to sustain and protect our agricultural base. By valuing the land needed for agriculture, the Current Use Program was established to put a fair value for taxation on the land used by farm families in the production of food and fiber rather than for building lots or potential development. This program has been successful with proper funding. The Land Trust concept began shortly afterwards in 1978. Instead of being taxed annually at the lower value for ag land, farmers could choose to sell their development rights to a statewide or regional Land Trust, vowing to keep the land in farming in perpetuity. Sometimes a few building lots have been held out for future family on the farm, but this allowed farmers to get a nest egg to use in future improvements in buildings, livestock, equipment, or more land to keep their farms viable.

Today, Vermont and the Feds have several programs, some like insurance on dairy revenue, assistance in buying that insurance to reduce risk, assistance with meeting more and more environmental requirements, and technical assistance to make their farms even more resilient to changing weather patterns and proximity to waterways and nutrient management. Agriculture and the environment will always go hand-in-hand. The UVM Center for Sustainable Agriculture has been around since 1994. They also provide research and cultivate partnerships, as well as providing

technical services to our farmers around the state. I commend Blue Spruce and Champlain Valley Pomona for their Ag Resolution on Sustainable Agriculture. I would challenge us all to remember the part we can play in this system of food production. Grow your own food, share, and don't let it go to waste.

Remember the commitment to composting our waste. Use less, reduce more. Recycle all we can. Carpool, drive less, walk more.

As Grangers, we can all be practical and thoughtful in the way we live our daily lives. We all need reminders, and the burden can't be placed solely on farmers and their ability to grow so much of the food we need for sustenance, if the food prices don't meet the production cost.

#### **Historical Record about Gassetts Grange**

FINALLY, FINALLY I have been able to attempt to duplicate the minutes of the Gassetts Grange meeting in 1904. Beautiful penmanship, but difficult to read. Many abbreviations were used. No guarantee on the spellings or correct interpretation of the notes!!!!

#### **Historical Record Gassetts Grange #327 Gassetts, Vt. Dec. 17, 1904**

The people of Gassetts met and organized a Grange to be called Gassetts Grange, the Worthy Deputy E. F. Whitcomb. Organized said Grange. There was a committee appointed to bring in a list of Officers. The following were reported and accepted by the Grange. After a short recess, the Officers were installed, except the Treasurer, who was not present. Sister Bertha Whitcomb acted as Asst. The Officers are as follows: Mr. Frank Dechafragh, W.M. Mr. W. A. Diaz, W.O. Mr. J. le Griddings, W.S. Mr. E. P. Putman Asst. Steward. Mrs. Winnie Putman, Lady Asst S. Mrs. Pricilla Johnson, W. Chap. Mrs. Myron Chandler, W. Lec. Mr. P. R. Earle W. Treas. Mrs. Minnie Lawrence, W. Sec. Mr. John Chandler, W. Gate Keeper. Mrs. S. de Griddings, W. Pomona, Mrs. Will Day W. Flora, Mts. Ida Parks W. Series. It was voted to have the next meeting in two weeks from tonight at 8 o'clock in Lockwoods Hall.

**Broad Brook Grange #151** - On Saturday, October 22, the official reopening celebration of the Broad Brook Community Center in Guilford Center, Vermont, took place. This marked the completion of a monumental renovation project that was sparked in 2013 by community visits held with the Vermont Council of Rural Development. As a result of those visits, an independent committee of residents and Broad Brook Grange members began discussions to undertake renovation of the Grange Hall. Now, nine years later and the investment of over \$2.1 million, the former Grange Hall has

been transformed with improvements that both modernize yet keep its historic presence to meet the needs of the community for the next 100 years. It also included the dedication of a National Register of Historic Places marker for the hall. We will be discussing the results of the State Grange annual session as well and will start looking at topics about which we can compose Resolutions for next year's session.

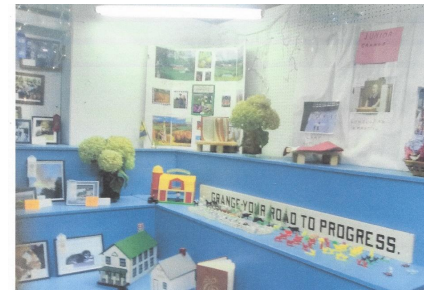
